Dear Federal Way Amateur Radio Club,

As an "exempt" organization, Federal Way Amateur Radio Club is not required to renew annually or provide our office with copies of its financial information (e.g. IRS federal returns). However, if the organization engages in one or more of the following activities, its exemption from registration is invalid and annual registration will be required:

- Raising \$50,000 or more in any accounting year
- Paying officers, employees or other persons
- Contracting with a paid commercial fundraiser or fundraising entity

If the organization's exemption becomes invalid, please contact the Charities Program for the appropriate form and instructions.
